(the "Issuer"), Blackstone Private Credit Fund ("BCRED") directly holds 545,996 shares of Common Stock, BCRED Twin Peaks LLC ("Twin Peaks") directly holds 290,246 shares of Common Stock, GSO Barre des Ecrins Master Fund SCSp ("GSO Ecrins") directly holds 125,840 shares of Common Stock and GSO Orchid Fund LP ("Orchid") and together with GSO III, BCRED, Twin Peaks and GSO Ecrins the "Blackstone Holders") directly holds 209,042 shares of Common Stock.

GSO Capital Opportunities Associates III LLC is the general partner of GSO III. GSO Holdings I L.L.C. is the managing member of GSO Capital Opportunities Associates III LLC.
